He is against any kind of War.

WALT WHITMAN

Walt Whitman was very much influenced by the Gita we can say that because he talks about life after death in his poems. He felt that there is one supreme energy which resides inside everyone. God has created everyone equal he says if the sun doesn't discriminate among human beings and other living beings so why should I discriminate.

Walt Whitman believes in rebirth life after death. Walt believed in the theory that there is life after death. We all only change bodies and soul is eternal.We are born as leaf.After death he tells he child.He tells the child who ask him what is this a grass? All are part of one supreme energy. Hatred and jealousy is not its nature therefore we need to avoid it.
